

OBER'S 2020 SKI VACATION GIVEAWAY OFFICIAL RULES

How to Enter the Giveaway: One winning package will be awarded on Tuesday, December 24, 2020. Entries will be accepted from December 14 until 11:59pm Wednesday, December 23, 2020. To enter the Giveaway, you must visit the official Giveaway landing page (www.obergatlinburg.com/win) and submit a form providing the following mandatory information: first name, last name, email address, phone number, address, (v) and confirm that he/she has read and agreed to the Giveaway rules, before the Giveaway Closing Date, to be entered. Any person who has completed the online entry form is eligible for the Prize as defined below. Dates and Prizes are non-transferable. Blackout dates do apply.

Eligibility: No purchase necessary to participate and win. Ober Gatlinburg (hereafter referred to as the "Giveaway partner") has the right to determine the eligibility of Giveaway winner. Employees of the Giveaway partner, their immediate families (spouses, parents, children and siblings, and each of their respective spouses), and members of the household of such individuals are not eligible to register for the Giveaway. The Giveaway partner has the right to determine eligibility.

Within the days following receipt of confirmation that the winner received notification about their Prize, the Organizer of the Giveaway will contact the winner to inform him/her of how to claim the Prize.
